I request that the North Dakota Museum of Art bid on the following objects in increments appropriate to competitive bids up to the maximum price I have indicated for each. I understand the Museum will keep my top limit of bid confidential.

I understand that the North Dakota Museum of Art executes absentee bids as a convenience for clients and is not responsible for inadvertently failing to execute bids or for errors relating to execution of bids. If identical absentee bids remain, the North Dakota Museum of Art will give precedence to the first received.

Successful bidders will be notified and invoiced on the next business day after the sale. Bidders with credit card information will be charged the evening of the auction. Shipping and handling charges are the responsibility of the buyer. In September 2002 the Office of the North Dakota State Tax Commissioner determined that the gross receipts from the sales made at the Auction are subject to sales tax. State sales tax is 5% of the total sale and the Grand Forks city tax is 1.75% of the first \$2,500 of the sale. The amount of purchase greater than \$2500 taxed by the city entitles purchaser to apply to the state of North Dakota for a refund of city tax collected on that portion. Out-of-state buyers who have the work shipped to them will not be subject to North Dakota sales tax.
